I submit my report as under:


- The Notice was sent to all the Members, whose names appeared in the Register of Members as on 12th August, 2016 to vote on the proposed 7 (Seven) Resolutions as mentioned in the Notice of the Annual General Meeting of "Salona Cotspin Limited" (Item No.1 (One) to 7 (Seven) of the Notice of Annual General Meeting of Salona Cotspin Limited. The Members holding equity shares as on the cut-off date i.e. 9th September, 2016 were only considered for e-voting and for voting at the meeting venue.
- 2. The E-Voting period remained open from 09.00 AM on Monday 12th September, 2016 up to 05.00 PM on Thursday 15th September, 2016.
- 3.
